5. Revision of the IPRB Dicamba Highly Volatile Herbicide (HVH) Determination

Over-the-top (OTT) dicamba soybean product registrants have requested that EPA change the application cutoff date to June 12th in IA, IL, IN to reduce off target incidents. **MOTION** by Martha Clark Mettler to support registrant & EPA request to change application cutoff date to June 12th and to leave application date for all other dicamba products June 20th, seconded Bruce Bordelon, **VOTE** unanimous.
