Request that OISC develop some guidance to assist with the understanding of the federal requirements for direct supervision of noncertified applicators using RUPs.

Summary Comment: Any part of current SB No. 216 could change as part of the legislative process. All explanations of SB No. 216 are based on the introduced version, as of this date.

Concern about being able to comply with school pesticide notification registry requirements in SB No. 216, if GUP record keeping at schools is no longer required. Current draft still includes pesticide manufacturer, brand name, and EPA Reg. No. as part of the advance notice requirement. If GUP applicator licensing and GUP record keeping requirements are rescinded, IDEM will be required to evaluate whether the terms of the Pesticide General Permit for the NPDES requirements can still be satisfied.
